Jharkhand vide Resolution No 30720/SME, did 23.9.1996 No objection certificate is granted in favour of Jharkhand Public School Dakra, for a period three years to open an un-aided Secondary School upto Class-X for the purpose of obtaining affiliation from the CBSE/ICSE subject to the following terms and conditions.

- The 'No objection Certificate 'now issued shall be subject to the terms and condition as prescribed in the G.O No 30720-SME did 29.9.1996.
- The Land is to be recorded in the name of institution and copy of the record of the rights to be furnished by the authority of the institutions within one year from the date of issue of the order.
- Own building of the school should be completed as per the norms on its own land within one year.
- Medium of instruction in the school shall be English but Hindi shall be laught as a subject to all pupils in the institution compulsory.
- 5. The School shall be open for the inspection by the inspection team.
- 6. No financial assistance and grant-in-aid (both recurring and Non-recurring) will be claimed by the institution from the Govt. at any point of time for meeting the salary cost and its component towards teaching and Non teaching staff appointed by the managing committee.
- The M.C of school will not shift the present location of the school without prior approval of Director, Secondary Education Jharkhand.
- 8. The untrained teachers will have to acquired training qualification within three years .
- The high power committee shall review the N.O.C granted to the institution concerned in the next HPC after elapse of one year and shall withdraw the same if the terms and conditions contained in the G.O No-30720/SME, did 23.9.96 is violated at any time.

10. The Managing Committee shall be constituted in accordance with the section-7 of the Jharkhand, Education Act-1969.
